

## Council approves amended stormwater fee increase

WESTFIELD - On Thursday, June 20, the City Council voted 7-5 to pass an amended stormwater fee increase after a year of debate. The new fees as amended by At-large Councilor Daniel Allie on the floor at the meeting, will raise residential rates from \$20 to \$30 beginning on July 1 for fiscal year 2020, to remain at \$30 for fiscal years 2021 and 2022.

The plan as voted lifts the cap of \$640 a year on commercial ratepayers, and raises it to \$1,200 for businesses with impervious surface of 80,000 to 150,000 square-feet and \$2,100 for parcels greater than 150,000 square-feet.

Allie said they negotiated the rates, which are set by the City Council, with Department of Public Works Director David Billips, who he commended for working with them. "These projects need to be done. We needed to get this revenue going," Allie said, adding that as part of the plan they had worked out a way to try to save small businesses some income.

The plan also lowers the rate from 4.5 cents per square-foot to 2.0 cents per square-foot in FY20, and 2.4 cents in fiscal years 21 and 22. Small businesses will see their annual rates decrease, Allie said.

"Under the old commercial rate, small businesses unfairly paid the same rate as the largest businesses. Most small and medium businesses will see their rates go down. Many of these small businesses are owned by Westfield residents," he said.

Currently, there is \$725,010 in the Stormwater Undesignated Account, which receives \$558,342 in revenues each year. The rate hasn't changed in ten years.

Under the new rate, the projected revenue for FY20 will be \$691,680, increasing to \$810,380 FY20, and \$874.180 in FY22 and FY23.

Before it was amended on the floor at the City Council meeting, the ordinance as approved by the Legislative & Ordinance sub-committee was for residential rates to

increase by \$10 per year for the next three years; from the current \$20 annually to \$30 in 2020, \$40 in 2021 and \$50 in 2022.

The commercial cap for businesses with impervious surfaces over 150,000 sq. ft. was also recommended by L&O to increase to \$5,000.

'There are some huge companies in the greater than 150 square-foot range. Our thinking in L&O was they could afford \$5,000," Ward 6 Councilor William Onyski said in presenting the proposal.

Onyski went on to say that with the increase proposed by L&O, the current annual stormwater revenue of \$550,000 would double to \$1 million in three years, which matched the revenue needed for the capital improvement plan.

"Personally, I think as a ward council this would help get a lot of the roads fixed," Onyski said.

Onyski also read the list of projects that would be paid for by the increased stormwater fees, as listed in the DPW's stormwater capital plan.

The three-year plan defined and limited the work, and provided the resources to projects such as washouts, structural repairs, replacement and drainage issues at Crescent Circle, Ridgeway Street, Indian Ridge, the Rail Trail. Notre Dame. Crane Avenue. Canal Drive. Glenwood Drive, Western Circle, Old Farm Road, Shaker Road, Alexander Place, City View Blvd, Ridgecrest Drive, Mather Street, Highland Ave. Butternut Road and Prospect Street Ext. Knox Circle, Skyline Drive, Spring Hill Road, Old Holyoke Road, Northwest Road, Honey Pot Road, Berkshire Drive, Ridgeway Street, Upper Montgomery Road and Caitlyn Way.

The City is also responsible for the Arm Brook and Powdermill Levees. These structures are 50 years old and currently being evaluated by the Federal government, and are eligible for federal funds, if the city has a

#### Free summer lunches include chance of a 'golden ticket'

WESTFIELD — Every year the need increases to provide free lunches for young people during the summer months, according to Kellie Brown, director of operations at the Boys and Girls Club of

"We expect to serve 27,000 individual meals to kids, ages 2.9 to 18, this summer which will be 1,500 more than last year," said Brown, adding that a postcard was recently distributed to every household in the city so that families are aware of the free lunch program that is coordinated by the Boys and Girls Club.

"All meals follow the guidelines of the Massachusetts Department of Education," said Brown, noting lunches include milk, a main component which can range from sandwiches to a hot meal including hamburgers or hot dogs, fruit, vegetable, and

## Food pantry experiences \$10K shortfall

### Donations urgently sought

WESTFIELD — \$10,000. As the fiscal books close on June 30 for the

Westfield Food Pantry, Executive Director Rebecca Hart sent out an urgent plea on Facebook this past weekend that monetary donations are needed to make up a shortfall of \$10,000. "The biggest reason for our shortfall is the loss of

donations due to a change in the tax code," said Hart. "Since President Trump's critical change to charitable giving was made, our donations have not been the same."

Hart added that for corporations and individuals, there is "less incentive to give."

In addition to a drop in charitable donations, Hart said an "unseen expense" this past year also drastically impacted the bottom line.

"We have a walk-in refrigerator that needed a repair costing \$4,500,"

fresh produce as well as critical donations of fresh foods from supermarkets and restaurants.

Hart noted the repair was imperative to the pantry's ability to store

"We pride ourselves on being a lean organization so we feel any loss," she added.

As Hart reviews statistics, she notes that the pantry is serving 1,250 individuals each month, with 52% being children and 13% representing the senior community.

'We have seen the largest change in providing services in the past three years," said Hart. "People who are working are still struggling to feed their families.'

## School just ended, but a new rewards program aims to help teachers next year

## **South and Middle Ponds** to receive algae treatment

SOUTHWICK - The annual algae treatment of South Pond and Middle Pond is Tuesday.

Lake Management Committee member Richard Grannells said portions of both ponds will be chemically treated to control the growth of nuisance algae.

Swimming is restricted until June 26.

"It works really fast," said Grannells of the treatment.

About 40 percent of those ponds will be treated. Grannells said North Pond is not treated because water frlows from North to Middle

to South Pond and North is the deepest, coolest water. "Algae tends to grow in warm, shallow water," he said.

There are no restrictions on other lake uses.

"The copper sulfate used in the treatment works very quickly and we are only treating a small portion of the lakes," Grannells said.

Earlier this month all three ponds that comprise Lake Congamond were treated for other nuisance growth. Solitude Lake Management of Shrewsbury is conducting the treatment.

NEW YORK (AP) — Two siblings from the famed Flying Wallendas safely crossed Times Square on a high wire strung between two skyscrapers 25 stories above the pave-

Nik Wallenda is a seventh-generation acrobat, but this time, he said he was nervous. His sister, Lijana Wallenda, joined him Sunday night for the first time since her near-fatal accident in 2017, when she broke nearly every bone in her face.

The siblings walked from opposite ends of the 1,300-foot wire (396-meter) suspended between the towers, crossing each other in the middle, where Lijana Wallenda sat on the wire and let her brother step over her. Both then continued to the opposite

Their latest daredevil stunt was streamed live on ABC and watched by thousands of spectators from below. The two were wearing tethered safety harnesses required by the city in case they fell.

n June 24, 1983, the space shuttle Challenger carrying America's first woman in space, Sally K. Ride — coasted to a safe landing at Edwards Air Force Base in California.

## Massachusetts bill would test idea of universal basic income

BOSTON (AP) - A bill under consideration at the Massachusetts Statehouse is aimed at testing the idea of a universal basic income.

The long-shot bill would create a pilot program that would include 100 residents in each of three economically diverse cities or towns. At least one of the communities would be located in a rural part of the state.

Everyone participating in the program would receive \$1,000 a month for three years and agree to participate in a study.

After the three years are complete, the bill calls on the Department of Housing and Community Development to submit a report looking at the effects of the program, including whether a universal basic income could be used to address historic inequalities, including institutional racism.

A similar pilot program is under way in Stockton, California.

funding plan in place. Otherwise, the City could be responsible for millions of dollars in repairs and maintenance. Failure at either levee would pose a risk to the downtown area for flood control protection in the case of a major event, and the ability of homeowners' eligibility to buy flood control insurance, according to an email Allie provided after the meeting.

During the discussion of the fee increase at the Council meeting, At-large Councilor Cindy C. Harris said the Water Commission had approved a second plan, the one which Allie eventually proposed for a vote, which increased the residential rates by \$10 for the next three years, to \$30 for 2020, 2021, and 2022. She said she would vote against any plan that increased resi-

"People are outraged. I support everything that's being done. I have to vote no, as I have said many times," Harris said about the proposed residential increase to \$50 over three years.

Ward 3 Councilor Andrew K. Surprise also said he didn't agree with raising residential rates to \$50. "I'd be comfortable with \$30. I can't support it the way it is," he said.

At-large Councilor Matthew Emmershy agreed, pointed to the undesignated account having \$750,000, and suggested spending some of those funds. He said the Council could come back and revisit the fees in a year or two.

At-large Councilor Nicholas J. Morganelli, Jr. also stood at the meeting to make his statement. He said the solution is not to increase the fees, which he called a tax, but to get spending under control. "I'm voting no on this for residents," he said.

Ward 1 Councilor Mary Ann Babinski pointed to the positives in the plan, such as the fact that increasing the cap but decreasing the rate would provide a benefit to small business. "They might pay less than before from the stormwater fee," she said.

Babinski said on the north side, stormwater contributes to the pot holes, giving the example of water running down Campinelli Drive to Servistar, creating "canyons" every year. "We've already said we could amend this as we go along. That's up to us," she said.

At-large Councilor John J. Beltrandi III said he has had issues with increasing the stormwater rates all along, and agreed with Councilor Harris regarding the impact on residents.

At that point, Allie brought forward the second proposal that had been approved by the Water Commission, which increased the residential by \$10 to remain at \$30 for fiscal years 2020, 2021 and 2022, and lifted the cap to \$1,200 for businesses with 800 to 1,500 sq. ft. of impervious surfaces, and \$2,100 for businesses with greater than 1,500 sq. ft. Allie said the second proposal had also been approved by the Finance sub-committee.

Allie made the motion to amend, and the amended stormwater fee increase passed 7 to 5, with Councilors Allie, Beltrandi, Emmershy, Figy, Harris, LeFebvre, and Surprise voting to approve, and Councilors Babinski, Bean, Burns, Morganelli and Onyski voting no. Councilor David Flaherty was absent from the vote.



Like any household budget, Hart is diligent in watching costs and making the most of the available resources. The basic expenses for the Westfield Food Pantry run the gamut from liability insurance and the building's rent, to basic utilities including electric, phone and Internet services. Hart added that she has part-time staff which includes her 20-hour position overseeing the pantry's operations.

'Our connectivity services are critical for the operation," said Hart, adding that the pantry's waste management fees have also increased 200%

Hart stressed that all of the food that is collected - which she is enormously grateful for - also needs to be "managed."

The logistics for handling all of the ways that we receive food is vast," said Hart. "We are also fortunate to have volunteers who not only work behind the scenes organizing and checking the food that is received, but also we have volunteers who go into the community to pick up donations."

As Hart looks to 2020's budget, she has already been informed that HUD (Housing and Urban Development) federal funding will be \$1,400 less than FY '19.

'The HUD funding has always helped to cover some of the rent and utilities," said Hart, adding, "it was our stable source of only income."

Hart added that a \$1,000 deficit "here and there" can make a tight budget even more challenging.

"We are the largest feeding program in Westfield," said Hart. "When we lose a \$1,000 here and a \$1,000 there, that makes us question our sustainability."

For area residents who wish to make a donation to the Westfield Food Pantry, checks or cash can be dropped off during office hours - Monday, Tuesday and Friday from 9:30 a.m. noon, or Thursday from 5 -6:30 p.m. The office is located at 101 Meadow St. Donations can also be mailed to Westfield Food Pantry, 101 Meadow St., Westfield, MA 01085. 

# New phase in 2020 presidential race tests Dems' aggression

NEW YORK (AP) — The unwritten rules that have so far prevented the Democratic presidential contest from devolving into all-out conflict are about to be tested.

The early front-runner, former Vice President Joe Biden, has so far fended off the relatively gentle wrath of his rivals. The shortcomings of his most ambitious opponents like Vermont Sen. Bernie Sanders and Massachusetts Sen. Elizabeth Warren have been largely overshadowed. And the fiery concerns of lesser-known candidates, such as former Maryland Rep. John Delaney and entrepreneur Andrew Yang, have been all but ignored.

That dynamic now changes as Democrats enter the most consequential week of the young 2020 campaign season.

Ahead of a major fundraising deadline, the candidates will face each other on the debate stage for the first time on Wednesday and Thursday. The clash serves as a microcosm for broader questions looming over the field, one chief among them: Should candidates attack each other more aggressively or focus their fire on President Donald Trump?

There are no easy answers for candidates desperate for a break-out moment.

In an interview, Democratic National Committee Chairman Tom Perez downplayed simmering tensions between two sharply divided wings of the party. One demands bold action on health care and climate change, while calling for Trump's impeachment; the other favors a more pragmatic progressivism that confronts the same policy challenges with a bipartisan approach.

"What we do have is unity of values," Perez said, noting that virtually every Democrat seeking the presidency supports universal health care coverage, combating climate change and civil rights.

Indeed, no one expects the escalation that lies ahead for Democrats to sink to the level of the Republican presidential debates in 2016, which were plagued by deeply personal attacks that have come to define the GOP's take-no-prisoners approach in the age of Trump.

approach in the age of Trump.

Privately, the better-known Democratic candidates concede that an overly aggressive posture could backfire at this early stage. It's also unclear, in such a crowded contest, who would benefit should Biden or another top-tier candidate fall several

months before the first primary votes are cast.

"We're all going to focus on the issues," Perez said when asked about the debates. "We're not going to be talking about hand size." a reference to GOP personal attacks from 2016.

Underlying the calculus is a real concern among party leaders, donors and strategists that Democratic infighting could

ers, donors and strategists that Democratic infighting could threaten their chief goal: beating Trump.

But the lesser-known candidates cannot afford to be cautious. And for the first time, they will have the opportunity to voice their concerns on prime-time television facing their opponents.

"I'm offering real solutions and a lot of people in the race are offering impossible promises," said Delaney, a pragmatic former Maryland congressman who has been actively running for president for nearly a year with little national fanfare.

Allies of more liberal and better-known candidates, including Warren, are concerned that Delaney in particular will play into Republican hands by savaging their prescription for health care — a universal health care plan referred to as Medicare for All — on national television. Delaney said he would not shy away from his criticism of the plan, particularly his contention that it would outlaw private insurance.

Another moderate Democrat, former Colorado Gov. John Hickenlooper, is expected to echo a popular Republican talking point by highlighting his Democratic competitors' embrace of socialism. The business-minded Democrat has levied the same charge in recent weeks, but this time, he would be doing

# Pompeo in Saudi Arabia, Iran threatens more US drone attacks

DUBAI, United Arab Emirates (AP) — U.S. Secretary of State Mike Pompeo held talks Monday with the Saudi king and crown prince after days of mounting tensions following the downing of a U.S drone last week and after President Donald Trump pulled back from the brink of retaliatory military strikes on Iran.

Iran's naval commander, meanwhile, warned that Iranian forces would not hesitate to act again and shoot down more U.S.

surveillance drones that violate Iranian airspace.

The U.S. denies the drone, valued at more than \$100 million, violated Iranian airspace. Trump said he backed away from planned strikes after learning that 150 people would be killed but that military action remained an option.

On Monday, Pompeo held separate talks with King Salman and Crown Prince Mohammed bin Salman in the Saudi port city of Jiddah to discuss the escalation with Iran.

Pompeo wrote on Twitter that he had a "productive meeting" with King Salman and discussed "heightened tensions in the region and the need to promote maritime security" in the Strait of Hormuz near the Persian Gulf, through which roughly a fifth of the world's traded oil passes.

From the kingdom, Pompeo will travel to neighboring United Arab Emirates, another close U.S. ally. The regional stops, made on his way to India, may be aimed at reassuring Washington's Sunni Gulf Arab allies that the White House remains committed to maintaining pressure on Shiite Iran following Trump's last-minute about face, which likely raised questions about U.S. willingness to use force against the Islamic Republic.

In what it says are defensive moves, the U.S. has built up its military presence around the Persian Gulf in recent weeks.

Iran's naval commander, Rear Adm. Hossein Khanzadi issued a warning to Washington that Tehran is capable of shooting down other American spy drones that violate Iranian airspace. Khanzadi spoke Monday during a meeting with a group of defense officials in Iran.

"We confidently say that the crushing response can always be repeated, and the enemy knows it," Khanzadi was quoted as saying by the semi-official Tasnim news agency.

Tensions have been escalating since Trump last year withdrew the U.S. from a global nuclear deal with Iran and reimposed economic sanctions on Iran. A fresh round of U.S. sanctions is to be announced later on Monday in a bid to force the Iranian leadership into talks.

Iran has decried the U.S. sanctions, which essentially bar Iran from selling its oil internationally, as "economic terrorism."

Before boarding his flight to Saudi Arabia, Pompeo described the sanctions as a way to deny Iran "the resources to foment terror, to build out their nuclear weapon system, to build out

their missile program."

The hastily arranged Saudi visit by Pompeo, considered a hard-liner in the Trump administration, and the upcoming stop in the UAE come as both countries have expressed alarm over Iran's military reach.

Saudi Arabia and the U.S. have accused Iran of being behind attacks on oil tankers near the Persian Gulf over the past several weeks, while the UAE has been urging diplomacy to avert

On the eve of Pompeo's visit to the kingdom, Yemen's

Iranian-allied rebels attacked a Saudi airport near the Saudi-Yemen border, killing a Syrian resident and wounding 21 other civilians, the Saudi military said.

The Houthi rebels claimed they used bomb-laden drones in the attack on the Abha airport, the second in less than two

weeks. Drones were also used to attack a Saudi oil pipeline last month.

Saudi Arabia has been at war with the rebel Houthis in Yemen for more than four years. The Houthis say the attacks targeting

the kingdom are a response to relentless Saudi airstrikes on Yemen that have killed thousands. Before his departure to Saudi Arabia, Pompeo said talks will include discussion on "how we can build out a global coalition,

a coalition not only throughout the Gulf states, but in Asia and in Europe... to push back against the world's largest state sponsor of terror," referring to Iran.

But even as Pompeo delivered his tough talk, he echoed

Trump in saying the U.S. is prepared to negotiate with Iran, without preconditions, in a bid to ease tensions.

"They know precisely how to find us," Pompeo said.
Throughout the recent crisis, Trump has wavered between bellicose language and actions toward Iran and a more accommodating tone, including an offer for negotiations. Iran has said

it is not interested in a dialogue with Trump.


Trump initially said Iran had made a "very big mistake" and that it was "hard to believe" that shooting down the drone last Thursday was not intentional. But he also said over the weekend that he appreciated Iran's decision to not shoot down a manned

U.S. spy plane carrying 30 people.
Iranian President Hassan Rouhani has blamed the United States' "interventionist military presence" for fanning the

U.S. military cyber forces on Thursday launched a strike against Iranian military computer systems, according to U.S. officials. The cyberattacks disabled Iranian Revolutionary Guard Corps computer systems that controlled its rocket and

missile launchers, the officials said.

Iran's Foreign Ministry spokesman Abbas Mousavi said
Sunday the U.S. "conducted a cyber operation contrary to international law."

Unlike some of his competitors, Sanders has not held mock debates to prepare for the upcoming faceoff, according to senior adviser Jeff Weaver, who described such preparations as an "inefficient use of time" in such a crowded field, especially given Sanders' experience on the debate stage in 2016. The Vermont senator has focused instead on studying written materials and preparing more succinct answers to accommodate the limited speaking time available to each candidate.

"We obviously expect there will be attacks coming our way. We will be prepared to appropriately parry," Weaver said.

Biden, already under fire for several weeks as the undisputed front-runner, expects to face continued questions about his positions on abortion, trade and fundraising and his willingness to reach across the aisle to work with Republicans — and even segregationists — in the past. New Jersey Sen. Cory Booker, California Sen. Kamala Harris, Sanders and Warren have seized on Biden's comments in recent days, which could be particularly relevant in the critical fight for African American voters.

"The dynamic is very simple: 19 against 1," Biden adviser Anita Dunn said. Still, with 10 candidates on stage each night, the veteran strategist suggested the initial debates would resemble "a joint press conference with 10 people" more than a prime-time food fight.

Harris, in the middle of the pack for now, is among those expected to take a cautious approach. Her rivals see her as a threat on the debate stage given her experience as a prosecutor and more recent performance in Senate hearings, but those who know her best suggest it's too early in the process to take unnecessary risks. She took a tougher line in South Carolina this weekend arguing that she's best positioned to take on

"The candidates with the most to gain will throw the sharpest blows. If you're at 1 or 2 points in the polls you're not going to move by playing it safe," said Brian Brokaw, a long-time Harris adviser who is not associated with the presidential campaign. "Middle-of-the-pack candidates have to figure out the best way to be noticed without being too thirsty."

It's a delicate balance many candidates are struggling with, especially knowing that Democratic primary voters want a nominee strong enough to take down Trump.

Virtually all the campaigns hope to have at least one key moment in the debate to break through the noise — and raise money. Most have teams prepared to blast out video highlights to supporters on social media through the weekend ahead of a key June 30 fundraising deadline. Biden is expected to announce that he raised more than \$20 million for the quarter, a number that could help strengthen the air of inevitability that currently surrounds his bid.

Veteran Democratic strategist Jesse Ferguson says that

Veteran Democratic strategist Jesse Ferguson says that breakout moments almost never come across as scripted. And very rarely do they come from attacking an opponent from the same party.

"People may obsess over which candidate attacks which candidate, but primary voters will be most compelled by the candidate who lays out a clear indictment against Trump," Ferguson said. "It may be much less about throwing elbows on stage and much more about throwing punches toward the general election."

Democratic donor Robert Zimmerman, a member of the

Democratic donor Robert Zimmerman, a member of the Democratic National Committee, is warning candidates of a backlash if they play too rough.

## Thousands turn out for new Boston-area casino grand opening

EVERETT, Mass. (AP) — Massachusetts' third casino officially opened its doors near Boston on Sunday to thousands of patrons, including some who had lined up in the early morning hours to finally get their first look at the glitzy \$2.6 billion Encore Boston Harbor facility after years of anticipation and controversy.

The crowd, which packed the pathways and harbor walk

The crowd, which packed the pathways and harbor walk that surround the tree-lined, waterfront casino complex, cheered as dignitaries and a handful of the roughly 5,000 new workers participated in the ribbon-cutting ceremony using oversized golden scissors. Puffs of brightly colored smoke could be seen for miles, shot into the air following a count-down. Wynn Resorts expected 50,000 visitors Sunday.

The facility, which features a 671-room bronzed-toned hotel tower, a gambling floor with 3,100 slot machines and 231 table games, 15 bars and restaurants, shops, lavish art displays, sits on 33 acres of formerly industrial land along the Mystic River in Everett, Massachusetts. It was billed Sunday as opportunity to finally transform the reputation of a city of more than 46,000, just north of Boston.

"When you drive through Everett, you'll no longer smell gas and sulfur and oils. But you'll smell flowers and trees," Mayor Carlo DeMaria told the enthusiastic crowd, which included many of his residents. "We will no longer be the back door to the city of Boston. We will now be the front door to the city of Everett."

Emotional at times, DeMaria thanked his wife and family for supporting him throughout the challenging process of getting the casino complex built, which took more than seven years. The development project involved an environmental cleanup of a former chemical plant. The project has also been mired in controversy since Wynn Resorts won the lone state gambling license reserved for the wealthy and populous Boston area nearly five years ago.

Casino regulators in Massachusetts and Nevada hit Wynn Resorts with \$55 million in fines and other penalties after determining officials failed to investigate allegations of sexual misconduct against Steve Wynn, the company's founder. Wynn has denied the misconduct allegations but resigned as CEO last year. And the company, weeks before opening, negotiated to sell the Everett casino to MGM, but those talks

ended amid public criticism.

However, Matt Maddox, the new CEO of Wynn Resorts, recently told The Associated Press "the controversy is behind us" and "our eyes are on the future." The Everett facility is the company's first casino outside the gambling centers of Las Vegas and Macau.

Glenn Reynolds, 65, of Quincy, was so excited about the new casino that he arrived 17 hours before the doors opened so he could be first in line. He spent much of the time waving to drivers and giving interviews to reporters. He told MassLive.com that he has waited for hours outside Fenway Park on opening day as well. But for this occasion, he brought a homemade sign with the words "Encore" and "Great!" with an American flag sticker.

"With (Encore) when I saw it and I said 'I'm going to take it up a notch," Reynolds said. "I'm going to make a nice sign, come here and enjoy this casino."

During the speaking part of the ceremony, Maddox recalled standing with DeMaria about seven years ago on the property when there wasn't a blade of grass.

"Now there's a thousand mature trees, 50,000 flowering plants, tens of thousands of shrubs and a living shoreline for the first time in 100 hundred years," said Maddox, who told AP he envisions Encore Boston Harbor becoming a template for the company's future and the casino industry more broadly as Wynn Resorts continues to extend its reach to other cities.

DeMaria promised to continue efforts to redevelop Everett's industrial waterfront area, including improvements to rail and water transportation.

"We're going to take this Superfund site," he said, referring to the federal program to clean up and redevelop contaminated land, "and make it a super site."

## **Senior Facebook** executive says it would favor regulation

LONDON (AP) — A senior Facebook executive says the social media site is in favor of regulation to address some of the dark problems of the internet.

Nick Clegg, the former leader of the U.K. Liberal Democrat party who now heads global affairs for Facebook, says it is not "for private companies" to decide how to balance free speech versus public harm.

Clegg told the BBC on Monday that companies like Facebook are not "shunning" government intervention but advocating a "sensible way" forward in addressing issues such as cyberbullying or fake news.

Lawmakers have been pushing tech companies to take down offensive content more quickly and to do more in general to halt internet harm. But Clegg says it is up to "democratic politicians in the democratic world" to set the

#### Coca-Cola extends as Olympic sponsor in China deal to 2032

LAUSANNE, Switzerland (AP) — Taking Coca-Cola's sponsorship beyond 100 years, the IOC has extended with Coca-Cola from 2021 through 2032 in a first-ever joint commercial deal with Chinese dairy company Mengniu. Coca-Cola's partnership with the IOC began at the 1928

Summer Games and will now stretch to 104 years.

While the Atlanta-based drinks giant is an Olympic fixture, the deal helps 20-year-old Mengniu's ambition to turn its milk and yogurt drinks business into a global brand.

The value of the deal was not disclosed at a signing ceremony Monday. The Financial Times citing anonymous sources reported it could be worth \$3 billion with up to half in cash sponsorship.

"The agreement includes unprecedented investment in traditional and digital media to promote the Olympic values globally," the IOC said in a statement.

Chief executives of both companies — James Quincey of Coca-Cola and Mengniu's Jeffrey Lu — joined IOC President Thomas Bach to sign the agreement ahead of a day-long meeting to pick the 2026 Winter Games host. Milan-Cortina from Italy is the long-time favorite against Stockholm-Are from Sweden.

Beijing is the 2022 Winter Games host, and China's internet giant Alibaba is already one of the 13 top-tier Olympic

Mengniu and Coca-Cola had separate sponsorship deals with FIFA for the 2018 World Cup in Russia.

Coca-Cola is signed with FIFA through 2030, while Mengniu has not yet renewed its one-tournament deal.

China would be a strong contender to host the 2030 World Cup when FIFA clarifies a potential rule to permit bidders from Asia so soon after the 2022 World Cup in

#### Clean water grants available for agriculture programs

MONTPELIER, Vt. (AP) — The Vermont Agency of Agriculture, Food and Markets is again releasing up to \$500,000 in grants for agricultural programs that address water quality.

The proposals are due by Aug. 1.

The agency is seeking programs focused on regulatory compliance; agricultural non-point source pollution reduction; and economic and environmental viability on Vermont farms.

Eligible activities include organizational development, conservation equipment maintenance and on-farm conservation practice surveys. Non-profit organizations, farm associations

and businesses are eligible for the grants. Agriculture Secretary Anson Tebbetts says the program "helps provide partner businesses and organizations with the tools and resources they need to run conservation programs and

impact change at the local level." The funding comes through the Clean Water Fund, which was created as part of Vermont's Clean Water Act.

## China says US-China trade teams in contact ahead of G-20

BEIJING (AP) — Chinese and U.S. trade negotiators are discussing ways to resolve disputes ahead of a meeting between Presidents Donald Trump and Xi Jinping at the G-20 summit in Japan later this week, a Chinese official said

The sides were seeking to "consolidate the important consensus reached between the two leaders" in a telephone call last week, Wang Shouwen, a Commerce Ministry vice minister, told reporters. Wang gave no details about specific issues under discussion.

This week's G-20 meeting in Osaka is the first opportunity Trump and Xi have had to thrash out the trade dispute faceto-face since Trump said he was preparing to target the \$300 billion in Chinese imports that he hasn't already hit with tariffs, extending them to everything China ships to the United States.

Trump has already imposed 25% tariffs on \$250 billion in Chinese imports and China has retaliated with tariffs on U.S.

The two sides are in a stalemate after 11 rounds of talks that have failed to overcome U.S. concerns over China's

acquisition of American technology and its massive trade surplus. China denies forcing U.S. companies to hand over trade secrets and says the surplus is much smaller than it appears once the trade in services and the value extracted by U.S. companies are taken into account.

Stepping up the pressure on Beijing, the U.S. Commerce Department has effectively barred U.S. companies from selling or transferring technology to Huawei Technologies, the world's biggest maker of network gear, No. 2 smartphone manufacturer and a champion of Chinese industry

Washington claims Huawei poses a national security threat because it may be beholden to China's ruling Communist Party. However, American officials have presented no evidence of any Huawei equipment serving as intentional conduits for espionage by Beijing.

Huawei's placement on the U.S. government's Entity List is widely seen as intended to persuade resistant U.S. allies in Europe to exclude Huawei equipment from their next-generation wireless networks, known as 5G.

Responding to a question about whether it would be best for all 5G devices sold in the U.S. to have been made outside of

China, Chinese foreign ministry spokesman Geng Shuang said Americans seemed to be conjuring up non-existent

"I want to tell individuals in the U.S. that they have been living in a panic made by themselves, and they have reached a state of extreme nervousness in which they even apprehend danger in every sound," Geng said.

Globalization has brought an "unprecedented" level of division of labor across borders and societies, reducing the significance of where products are manufactured and assembled, Geng said.

"Against such a backdrop, any attempt to achieve 'absolute security and controllability' by isolating oneself is nothing but fool's talk," Geng said.

China has responded to U.S. pressure by saying it would issue a list of "unreliable entities" targeting companies that "violated market principles" and cut supplies of components to Chinese businesses for non-commercial reasons.

Beijing has also suggested it might limit exports of rare earths, minerals such as lithium that are used in many products including cellphones, electric vehicles and the batteries that run them.

## States' push to legalize sports betting differs by region

CHERRY HILL, N.J. (AP) — In the year since the U.S. Supreme Court cleared the way for every state to legalize sports betting, a regional divide has opened as states decide whether to expand their gambling options.

By year's end, legalization is possible in a dozen states in the Northeast and Midwest. But most states in the Deep South and far West — SEC and Pac-12 territory in college sports — are staying on the sidelines, at least for now.

State lawmakers are weighing the benefits of a slight boost in state revenue and the ability to add consumer protections against concerns about the morality of allowing another form of gambling. Sorting out complex business interests and opposition from some casino-operating tribes also has emerged as thorny challenges.

It's not clear whether legalization will happen in all corners of the country over the next few years or if opposition will keep it concentrated in the regions where it's already taken root.

With just two exceptions, the Deep South states have been among the most resistant to legalizing sports betting. In Louisiana, a legalization bill passed the Senate earlier this year but died in the

Republican state Sen. Danny Martiny favors legalization, saying Louisianans already are betting on sports through bookies, offshore websites and casinos in neighboring Mississippi. He said Louisiana should regulate and tax sport bets, with the receipts largely earmarked for early childhood education.

'We have all of the ills of gaming," Martiny said during a committee hearing, "but none of the benefits."

Opponents such as Rep. Valarie Hodges, also a Republican, said gambling preys on the poor and that the state should find a better way to pay for early education.

"What we legalize, we legitimize," she said.

Hodges' side prevailed in the legislative debate, aided by a dispute among gambling interests over whether sports betting should be limited to the state's 16 casinos and four racetracks or also available at 2,800 truck stops and other locations with video poker ter-

Before the May 2018 Supreme Court ruling that allowed sportsbooks across the country, full-service ones were running legally only in Nevada. Last year, they opened in seven more states. So far this year, sports books have been legalized but haven't yet begun operating in another five, plus the District of Columbia.

Bills are awaiting signatures from the governors in Illinois, Maine and New Hampshire. Colorado voters will decide the matter for that state in November. In Oregon, the state lottery is working on regulations with the plan of launching sports betting under existing law in time for the start of the NFL season.

Four more states are considering legalization during their current legislative sessions, but most legislatures have wrapped up their work for the year. Lawmakers in 18 states rejected sports betting legalization bills for 2019, according to a tally of legislation by The Associated Press.

There are several other states where lawmakers might have an

appetite for legalization, but there isn't agreement in the complicated and tightly regulated gambling industry on how or whether to

A common factor in those places, including California and Florida, is the prevalence of casinos operated by Native American tribes. Agreeing to allow sports betting might mean the tribes would

face increased competition. Chris Grove, a gambling industry strategist at Eilers & Krejcik, said he expects several states — mostly in the Northeast and upper Midwest — to legalize sports betting in the next year, and then for the spread to slow because the remaining states are reluctant to

allow gambling generally or because of tribal influence. "As you move farther west, the more complex the stakeholder picture and the harder it is to get anything done," he said.

But Bill Pascrell III, a lobbyist for some gambling companies, expects that even some states that have been traditionally reluctant to legalize gambling will allow sports betting in the future. He points to Tennessee, a state without any casinos, deciding to legalize online sports betting

The absence of sports gambling in California, Texas and Florida, the nation's most populous states, leaves a gaping hole in the industry. They are home to more than a quarter of the teams in the four major professional sports and have about the same combined population as all the states that have adopted legalized sports betting including those where bills have been sent to governors but not signed into law.

Other states, including Utah and South Carolina, are unlikely to welcome sports betting anytime soon because it's difficult to sell any form of gambling there.

Over the past year, states with legal sportsbooks have reported about \$9 billion in bets being made. But sportsbooks are a relatively low-margin business for their operators, who pay taxes only

on how much they win, not how much is gambled. According to their most recent financial reports, three of the states with legal sportsbooks are on pace to bring in far less than they expected in taxes their first fiscal year. Mississippi is bringing in about half of what it needs each month to reach an informal state

target. Rhode Island and West Virginia are both on pace to bring in 20% to 30% of their expected revenue, according to an AP analysis. Even in New Jersey, where mobile betting has caught on quickly

sports betting taxes amount to far less than 1% of all state revenue. Washington state Rep. Derek Stanford, the Democratic chairman of a committee overseeing gambling activity, said he thinks the state is not ready for sports betting, and that's a reason none of the three bills to legalize it there gained traction this year.

He said the state needs to work through concerns ranging from the effects of legalized sports betting on public health to figuring out how it would affect tribal casinos.

"My sense is that we don't want to be the ones breaking new ground here," he said. "If other states are doing this, we can see what experience they have."

Dear Annie: As much as I hate to admit it, I think about divorce practically every day. Divorce, however, isn't something I want. What I want is for my husband to understand my point of view -- which is why I'm writing this letter. He reads your column religiously. Maybe my words will sink in when he reads them here rather than hearing them from me time after time.

Telling him how I feel has resulted in absolutely no change in his attitude. In some ways, it only made things worse. Everything becomes my fault. After being married to my husband for nearly 24 years, I'm tired of feeling like I'm no longer on his priority list. (Sadly, I know this is the case for many other wives out there.)

Gone are the days of feeling loved, cherished, protected and taken care of. The overwhelming feeling now is that of being taken for granted. Gone are the days of receiving heartfelt tokens of affection like a note, kiss on the forehead, comforting hug or a bouquet of wildflowers picked just for me. Now, I can hardly have a conversation with him without being met with a sexual innuendo

Gone, too, are the days when he'd help with household chores so that it wasn't all on my shoulders. My husband is at that age now where he no longer has to work. He is able to do as he pleases all day while I'm still working full time. Even though he now has all the time in the world to help with household chores, he chooses not to, leaving it up to me to do on the weekends.

I'm not sure what to do. Every time I bring it up, nothing changes. I'm made out to be the bad person. I'm not perfect, by any means, but I do still treat him much the same as I always have: with respect, unconditional love and support. I hope that I would deserve the same. The more he changes, though, the less love and respect I feel for him. -- Taken for Granted

Dear Taken: It's not just many wives but also plenty of husbands, boyfriends and girlfriends who have felt taken for granted. In fact, I'd say the No. 1 threat to long-term relationships is not becoming interested in other people but becoming uninterested in each other. Your husband reading this in my newspaper column isn't going to be the true breakthrough your marriage needs. However, you might be onto something with seeking another medium for your message. In this case, I think the best format would be marriage counseling. An objective third party can offer your husband perspective he might not be willing to hear from you. Plus, it will offer you insights into your own behavior you might not be expecting. Tell your husband how important it is to you that you go to counseling together, that you feel the health of your marriage depends on it.

Dear Annie: I just read the question from "Bad Mom." I, too, was trapped in the cruel cycle of addiction. I benefited from the support of the fellowship in Narcotics Anonymous and Alcoholics Anonymous multiple times only to relapse. For me to break free from substance abuse as a coping mechanism required professional counseling. There I learned how to begin to resolve deepseated psychological issues. The disease of addiction needs to be addressed on four levels -- physiological, psychological, sociological and spiritual. It sounds as though "Bad Mom," who was able to get clean and sober in the past, is aware of the physical aspects of addiction and likely received social and spiritual support through her church family. Perhaps the advice that she doesn't already know is that time working with a therapist could give her the ability to forgive herself for the person she's been. From there, she could finally benefit from the support of NA, AA and church

groups, as it has for me. -- Been There
Dear Been There: So well said. Thank you for outlining this

four-pronged approach to recovery.

## 'Toy Story 4' opens big with \$118M

NEW YORK (AP) — "Toy Story 4" brought the box office to life with a \$118 million opening weekend after a three-week slump of underperforming sequels, but the Pixar film's below-expectations debut didn't quell continuing concerns about a rocky summer movie season.

The "Toy Story 4" opening, according to studio estimates Sunday, ranks as the fourth highest animated film opening ever, not accounting for inflation. Above it are 2018's "Incredibles 2" (\$182 million), 2016's "Finding Dory" (\$135 million), and 2007's "Shrek the Third" (\$121 million). It's the year's third largest debut, trailing only a pair of other Disney releases: "Avengers: Endgame" and "Captain Marvel."

But heading into the weekend, a \$140-150 million opening had seemed assured for "Toy Story 4," which played in 4,575 North American theaters. Adjusted for inflation, the film came in shy of the \$110.3 million — or about \$129 million in today's dollars — "Toy Story 3" made nine years ago.

The opening for "Toy Story 4" followed a string of disappointing sequels including "Dark Phoenix," "Godzilla: King of the Monsters" and "Men in Black: International." But "Toy Story 4" had something those films didn't: great reviews. It rates 98% fresh on Rotten Tomatoes. Audiences gave it an A CinemaScore.

The sequel, which introduces the child-made plaything Forky (voiced by Tony Hale) to the voice cast including Tom Hanks and Tim Allen, also grossed \$120 million internationally, including a modest \$13.4 million in China, the world's second largest film market. It was trounced there by the rerelease of Hayao Miyazaki's 2001 animated classic "Spirited Away" from Studio Ghibli, the Japan animation studio that has often served as an inspiration to Pixar.

Cathleen Taff, distribution chief for Disney, said the company was thrilled with the opening and praised Pixar's high standards.

"The Pixar team has always been disciplined about making sure they have a compelling story to tell, and that is especially true when it comes to sequels if you look at their past," said Taff. "Their process of sort of going through the rigor of making sure that this is a story people want told, the end result speaks for itself."

The overall marketplace didn't give "Toy Story 4" much momentum. Last week's top film, Sony Pictures' poorly reviewed "Men in Black International" slid 64 percent, slip-

ping to fourth place with \$10.8 million

The No. 2 film, Orion Pictures' horror remake "Child's Play" — cheekily positioned as the weekend's R-rated toy movie — also opened below expectations with \$14.1 million. A remake of the 1988 original, the film stars Aubrey Plaza with Mark Hamill voicing the knife-wielding doll Chucky.

Luc Besson's assassin thriller "Anna" missed out on the top 10 entirely, opening with a mere \$3.5 million in 2,114 theaters. Lionsgate, which bought U.S. distribution rights in 2017, did little to promote the film in advance of its release. In 2018, Besson was accused of a rape by the actress Sand Van Roy. A lawyer for Besson denied the accusation and French authorities dropped the investigation in February citing a lack of evidence. Eight other women also accused Besson of sexual misconduct in a French publication.

In a summer season that's running 6.5% off the pace of last year, according to Comscore, many had positioned "Toy Story 4" as a surefire savior, due in part to the enviable track record of Disney and Pixar. (Disney's "Aladdin" remake this weekend passed \$800 million worldwide.) Instead, the weekend was down 27.2% from the same frame last year. Overwhelming the industry's market leader, Disney was thought immune to any sequel downturn. But most other studios would love to have a film under-

perform to \$118 million, with an expectation of long-term playability. Outside Sony's upcoming "Spider-Man: Far From Home," "Toy Story 4" has no family-friendly competition until Disney's own "Lion King" remake opens July 19. "The numbers being bandied about out there pre-weekend

were certainly much higher than the number that it came in with," said Paul Dergarabedian, senior media analyst for Comscore. "But if we bring it down to earth and put some perspective on this, it was still a franchise-high debut. It was a global opening of \$238 million."

But with underwhelming returns for even critically acclaimed comedies like "Booksmart" and seemingly surefire bets like "The Secret Life of Pets 2," little has gone according to plan in Hollywood's primetime season.

"The summer has been a real head-scratcher," said Dergarabedian.
